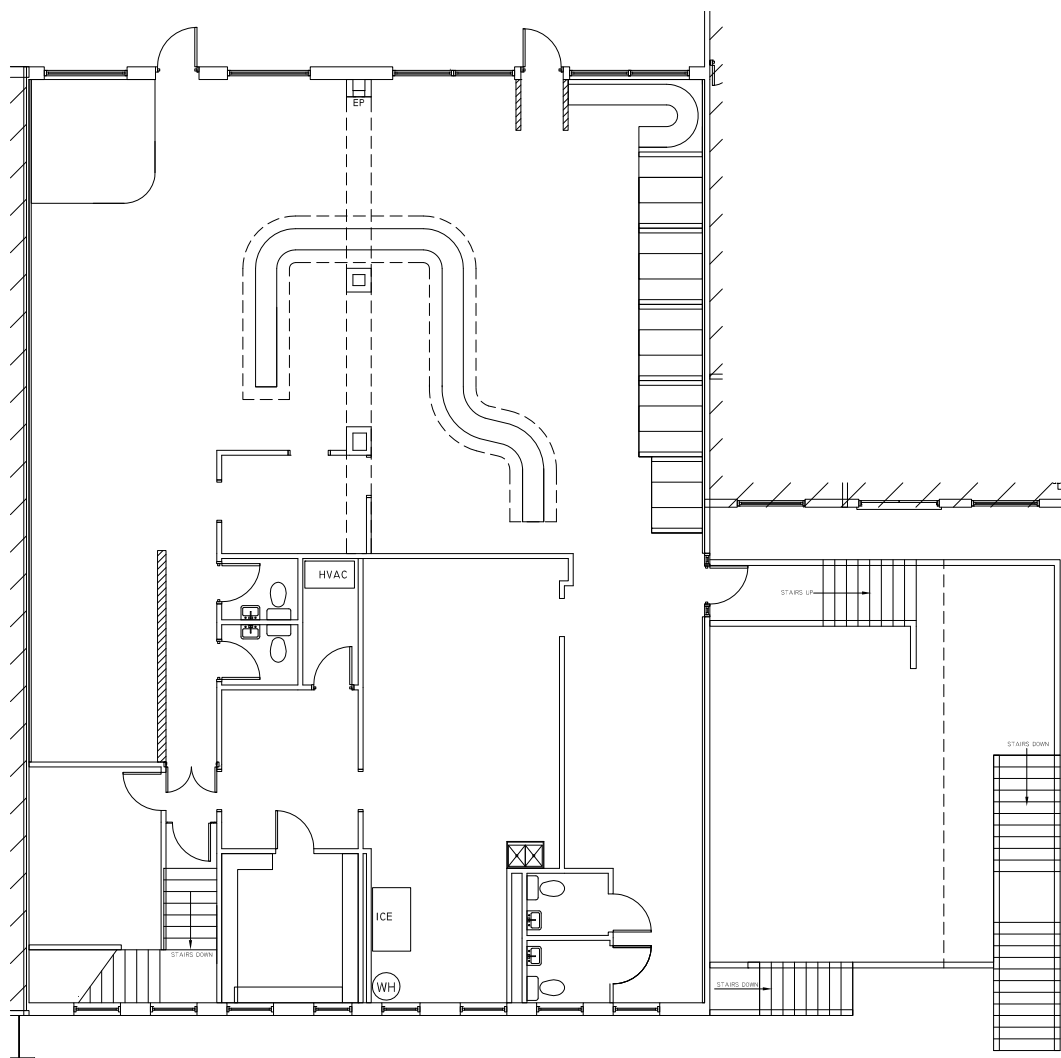

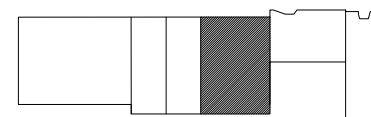


GLENWOOD AVENUE SE
